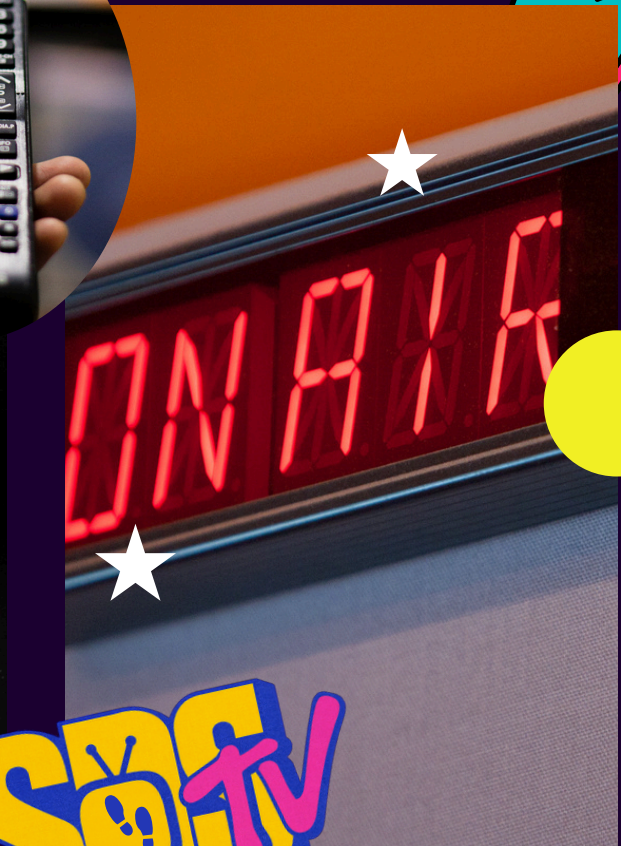

## **Commitment Agreement**

By signing below, I acknowledge that I am committing to participate in the Social Dance Studio Showcase on October 3, 2026, as well as the mandatory dress rehearsal on September 27, 2026.

I understand that once I sign up and pay for the showcase, I am contractually obligated to fulfill my participation in both events.

## **Attendance & Penalty Policy**

- Attendance at both the showcase and dress rehearsal is required.
- Failure to attend either event will result in a \$50 penalty fee per missed event.
- Fees may be waived only in the case of a verified emergency, at the discretion of studio management.

## **Deadlines & Fees**

- All dancers must be signed up and paid in full by June 30, 2026.
- Dancers who sign up after July 17, 2026 will incur a \$50 late fee.
- Dancers who withdraw from the showcase after July 17, 2026 are still responsible for payment of:
  - All lessons taken up to that point, and
  - The full showcase fee, as originally agreed upon.

## **Communication Policy**

I agree to check all showcase-related communications (email, text, group chat, or posted announcements) regularly and understand that I am responsible for staying informed about rehearsal schedules, costume requirements, and any updates provided by my instructor or the studio.

# **SOCIAL DANCE STUDIO SHOWCASE COMMITMENT CONTRACT**

## **Costume & Music Responsibility**

I understand that all costume and music selections for my showcase performance must be coordinated with my instructor and approved by the studio. Any additional costume or music costs are my responsibility unless otherwise stated in my showcase package.

## **Outside Performers**

All outside performers or guest dancers performing choreography not constructed by Social Dance Studio staff must submit a video or detailed outline of their performance prior to the dress rehearsal for approval by the Showcase Board.

All costumes for outside performances must also be pre-approved by Social Dance Studio staff.

No crude, sexually explicit, or suggestive content or costumes will be tolerated. Social Dance Studio reserves the right to require changes to any performance or costume that does not meet the studio's family-friendly standards, and all requested adjustments must be made in order to participate.

## **Photography & Videography Consent**

I grant permission for Social Dance Studio to photograph and/or record my participation in the showcase for promotional and educational purposes. I understand that these images or recordings may be used on social media, websites, or marketing materials, without additional compensation.

## **Behavior & Professionalism**

I agree to represent Social Dance Studio in a positive and professional manner throughout the showcase process, including rehearsals, dress rehearsals, and the performance itself. I understand that disrespectful or disruptive behavior may result in my removal from the showcase without refund.

## **Refund & Transfer Policy**

Showcase fees are non-refundable except in cases of verified emergency, at the discretion of studio management. In such cases, fees may be partially credited toward future lessons or events.
